

Visitation Guidelines Changes

Effective immediately, visitation guidelines are changing to the following policy outlined below. Please note: this policy is subject to change, based on regional community prevalence and/or positivity rate.

Other Guidelines for Patients and Visitors

COVID-19 Screening

Visitors will be screened for COVID-19 symptoms upon entry to any Phelps Health facility. Visitors will not be allowed to visit if COVID-19 symptoms are present. Anyone who has tested positive for COVID-19 or is quarantined from an exposure cannot visit until out of isolation or quarantine per primary care provider or health department.

Mask Usage and Hand Hygiene

All individuals (patients and visitors) entering Phelps Health facilities are required to wear a facemask or covering. Visitors will be encouraged to perform hand hygiene when entering and exiting any Phelps Health facility and a patient's room. Visitors are encouraged to stay six feet away from patients and others.

Limitations, Exclusions and Exceptions*

No one under the age of 16, with the exception of those seeking medical care, will be allowed into Phelps Health facilities. Exceptions will be made for obstetrics, labor and delivery. Siblings of a new infant will be allowed to visit even if they are under the age of 16. Visitors are asked to limit their movement within the hospital to only the patient's room and public restrooms.

*Exceptions to the visitor policy may be made by the department manager or designee, such as a charge nurse or supervisor.
